• B.A. LL.B. (Hons.) – 5 Years (Integrated Program)

(INTAKE: 120 Students)

- **Eligibility:** 10+2 or equivalent from a recognized board with a minimum aggregate percentage.
- Minimum 45% marks for General & OBC Category, 42.75% marks for SC/ST Category candidates
- <u>Course Structure:</u> The integrated program blends law and humanities subjects such as Hindi, English, History, Political Science, Sociology, and Economics, ensuring a comprehensive understanding of law in a broader socio-economic and political context.
- LL.B. (Hons.) 3 Years Program

(INTAKE: 120 Students)

- <u>Eligibility</u>: Graduation in any discipline from a recognized university with a minimum percentage as per MDU norms.
- Minimum 45% marks for General & OBC Category, 42.75% marks for SC/ST Category candidates
- Course Structure: The program covers core legal subjects, including Constitutional Law, Criminal Law, Civil Law, and Corporate Law, along with moot court exercises and internships.

ADMISSION PROCEDURE

- For LL.B. (Hons.) 3 Years program and B.A. LL.B. (Hons.) 5 Years (Integrated Program) interested applicant may get the prospectus from the administrative office of the college in working hours and may submit the same in prescribed time in the office up to 4.00 pm from Monday to Friday.
- Prospectus may also be downloaded from college website
- The admission form must be complete in all aspects and should be submitted in the office of the college. No online mode such as Email, WhatsApp etc. will be entertained and incomplete forms shall liable to be rejected.
- Five passport size latest photographs are to be attached at the back of the form.
- All the particulars and certificates enclosed with application form must be legible and 3 attested copies of all the documents to be enclosed along with the form.
- A candidate who is admitted on the basis of false / incorrect / suppressed information submitted by him or by his guardian and at any other subsequent time, if it is discovered that any portion thereof is incorrect or false or suppressed, his admission to the program shall stand cancelled. Fees and other dues paid by him shall be forfeited. The college may also take any suitable action against the said student and his guardian.
- Medium of instructions shall be English.
- B.A LL.B. (Hons.) 5 Years (Integrated Program) and LL.B. (Hons.) 3 Years program shall not be combined with any other program or apprenticeship except program in foreign language.
- College shall not register or enrol any student in violation of the merit list.
- The maximum period to complete a program is duration of the program +3 year, unless otherwise specified in any other ordinance of the affiliated university or the **BAR COUNCIL OF INDIA**, New Delhi.
- A candidate, who after seeking admission in a program left that program in-between and seeks admission in other program may be allowed to continue that said program, if he/she is able to complete the said program within the maximum period prescribed for completing a program which is the duration of the program +3 year, unless otherwise specified in any other ordinance of the affiliated university or the **BAR COUNCIL OF INDIA**, New Delhi.
- A candidate who has qualified the qualifying examination and has a gap period of more than 2 years or more, he/she can be granted admission to program if such a candidate submits an undertaking that during gap period he/she has not indulged in any illegal activities.
- Unless otherwise specified, there is no upper or lower age limit for admission in any legal program.

FEES STRUCTURE & REFUND RULES

- B.A. LL.B. (Hons.) 5 Years (Integrated program) is Rs. 45,000/- per annum
- LL.B. (Hons.) 3 Years program is **Rs. 60,000/- per annum.**

<u>FEES REFUND RULES:</u> If a candidate, after being admitted to the first year of program, leaves without attending any class or classes and requests a refund within 7 days of admission, the fee paid will be refunded after deducting Rs. 1000/- and if a candidate withdraws after 7 days of admission and their vacated seat is filled from the waiting list, the fee will be refunded after deducting 25% of the total annual fee, subject to a minimum deduction of Rs. 1000/- & if the seat vacated is not filled, the fee will not be refunded. These provisions are subject to the latest guidelines of the university, which may change from time to time.

CODE OF CONDUCT

ANTI - RAGGING CELL

The College for curbing ragging as conveyed by the UGC vide letter no. FA-1/97(CPP-II) dated 7th July, 2001 in view of the judgment of Supreme Court in civil writ petition no. 656 of 1998 'Vishwa Jagriti Mission Vs. Centre Govt.' given below shall be adhered to strictly.

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately, which may include expulsion from the college, suspension from the college or banned for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding scholarships or other benefits (ii) debarring from participation in events (iii) withholding results (iv) lodging of FIR with the local police. If the individuals committing or abetting ragging are not / cannot be identified, collective punishment can also be awarded to act as a deterrent.

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or in disciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to invoke fear or such tension thereof in fresher's or junior students or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student will be deemed an act of ragging. Hon'ble Supreme Court of India in SLP (c) No. 24295/2004 in the matter of 'University of Kerala Vs. Council of Principals, colleges of Kerala & others has ordered that if any incidents of ragging comes to notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the Institution.

It is mandatory to submit a self-declaration against ragging along with the admission form which is attached with the admission form.

<u>SEXUAL HARASSMENT COMMITTEE</u> (INTERNAL COMPLAINTS COMMITTEE – ICC)

The College has constituted an Internal Complaints Committee (ICC) in accordance with the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, and the UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015.

This initiative follows the guidelines laid down by the Hon'ble Supreme Court of India in the landmark judgment of Vishaka & Others vs. State of Rajasthan & Others (AIR 1997 SC 3011), which first defined sexual harassment at the workplace and mandated the formation of redressal committees in institutions.

Sexual harassment in educational institutions is strictly prohibited. Any student or employee found indulging in such misconduct is liable to face strict disciplinary action which may include:

(i) Warning written apology or Withholding benefits (ii) academic employment of or termination (iii) Suspension or from employment (for staff) (iv) Suspension expulsion from the institution (for students) or (v) Lodging of an FIR with the local police under applicable criminal laws

Sexual harassment includes any unwelcome behaviour of a sexual nature, whether directly or indirectly, such as:

- Physical contact and advances
- A demand or request for sexual favours
- Sexually coloured remarks
- Showing pornography
- Any other unwelcome physical, verbal, or non-verbal conduct of a sexual nature

The Internal Complaints Committee (ICC) is empowered to receive complaints, conduct inquiries, and recommend necessary action. The inquiry shall be conducted in a fair, confidential, and time-bound manner, ensuring natural justice to both the complainant and the respondent.

As per UGC norms, if any such incident comes to the notice of the authorities, the matter shall be forwarded to the ICC, and the concerned person shall be given an opportunity to explain. If the explanation is found unsatisfactory or the misconduct is established, disciplinary action will be initiated in accordance with institutional policies and legal provisions.

All students and staff are required to submit a declaration acknowledging awareness of and commitment to the prevention of sexual harassment, to be attached with the admission/employment form

INFRASTRUCTURE & FACILITIES

✤ <u>COLLEGE CAMPUS</u>

The college campus extends over an area of 11 acres of land situated close to Rohtak which is emerging as educational hub. The campus is divided into various functional zones like Administration Block, Lecture Hall, Library, Moot Court Hall, Computer Lab, Cafeteria, Placement Cell and many more.

✤ WELL EQUIPPED LIBRARY



The library is the heart of any academic institution and it is an integral part of academic endeavor in the college and is being constantly enriched by acquisition of latest Law Books, Magazines and Journals. The sitting capacity of the library is adequate and the working hours of the library are 9.30 am to 4.00 pm in the institute. A student can borrow three books at a time for 14 days. However books meant for reference will not be issued. The library is continuously in the process to acquire text books meant for reference books, to keep its reader abreast with the latest information. The library of the institution aims to facilitate academic & research activities. The college library is organized into various sections, which are managed by professionally qualified staff. The library is equipped with a **photocopy machine facility**, enabling students and staff to copy essential study material. Additionally, for the past **six years**, the library has maintained an active subscription to **Manupatra**, a leading online legal database. This provides students and faculty with easy access to judgments, statutes, notifications, legal articles, and more supporting both coursework and legal research.

* <u>SMART CLASSROOM</u>

To keep pace with modern educational advancements, the college has established a wellequipped **Smart Classroom** that integrates technology into the teaching-learning process. The classroom features an interactive digital board, LCD projector, computer system, audio-visual aids, and high-speed internet connectivity. This setup enables faculty to deliver multimedia-rich lectures and access online academic resources, making learning more interactive, engaging, and effective. The Smart Classroom is used for regular classes, guest lectures, webinars, and presentations, thereby enhancing the academic environment. * MOOT COURT HALL



There is a modern moot court hall in the college that is said to be the laboratory to test the advocacy skills of the students. The college strives to integrate the knowledge and practice of law through a regular and compulsory moot court practice where students learn to prepare and present their case. In this series, the college organizes inter moot court competitions in routine to make the students enhanced with legal skills. The students of B.A.LL.B.(Hons.) 5 Year (Integrated program) 10th semester and LL.B. (Hons.)3 Year program 6th semester have been facilitated for an internship and training under Senior Council in District Court, Rohtak.

✤ <u>COMPUTER LAB</u>

Our College of Law has a furnished Computer Lab that has a large number of 30 PCs with latest configuration. It provides facility of internet with high speed of 6 mbps optical fiber broadband

✤ <u>LEGAL AID CLINIC</u>



Article 14 of the Constitution of India talks about equality before law and Article 39-A provides for equal justice and free legal aid. As per the directions of the Hon'ble Supreme Court of India and Bar Council of India, New Delhi, the institute has set up a legal aid clinic to provide legal help to weaker section of the society, who are not able to approach the court. In co-ordination of the District Legal Service Authority, Rohtak (DLSA), the teachers and students of the institute organize the legal awareness camps and visit to rural areas to provide needy people legal free aid and help. This will help the students to get practical exposure and develop their legal skills by interacting with general public.

* MULTI PURPOSE HALL
